- III. Old Business
 - a. Website. Supervisor Richard DeNapoli successfully gained access to the website browardsoilandwater.org and began the process of updating contact info. Supervisor DeNapoli made a motion for the board to allow him to contact former Supervisor Schafer to gain access to the Facebook page. Supervisor Mike Solley seconds. Motion carries.
